1 [6.35]	Opening the Meeting - Apologies from MS - Action items: check above.
2 [6.45]	President's Report - Most items will be covered under the following headlines/subject topics - Networking event: Revision of funding system so that now there is one pool, from which groups can ongoingly apply for things as they need.

Treasurer's Report [possibly as an extension of President's report] [6.50] \$2762.33 Current Balance Payment made to P&C, but payment to Beyond Blue yet to be made. We need to check if AS is currently listed as the administrator of our Westpac account Marketing & Media [7.05] AC's idea that as people have ideas for news features that they message her. We can source this from general information from the residents, facebook page, etc. RM is going to make a spreadsheet for above so AC can then put that news on the website. Any admin posts can be done as Honeywood Residents Group now (ie, it is possible to do that now as a profile) Exetel Sponsorship – a few questions still remain. Do we want to consider it? What are some of the implications. Sponsorship packages open to any business? Creation of Sub-committee for the purposes of sponsorship funding avenues. **Memberships: Financial & Facebook** [7.15]MS wants to know if the group profile can now be used to field requests? RM to look into it RE Constitution revision notes: removing 'ordinary member' category, to avoid the situation where people who are not explicitly members feel misrepresented. Special meeting to be scheduled rather than making it part of AGM. Membership to be opened to Rural Wandi – both to facebook group and for financial membership. Constitution will need to be revised/is being revised accordingly. The original reason used to be for safety and security, but on the balance of things that doesn't seem to be a real concern. AS and JM already started working on the constitution; this is being circulated to the rest of the committee for feedback. **Community Security & Safety** [7.30] Next 'Cops on Your Corner' to be scheduled, likely after the Markets on a Sunday. We might get approved for Neighborhood Watch funding, which would give us money for a potential sausage sizzle just after/during the 'Cops on Your Corner.' Other funding ideas: eg CoK, and we should spruik the aspect that it's an innovation that will increase safety, and communication around security. We can refer to the fact that this is already getting attention in the media (Channel 9 Segment) MM went to the Aubin Grove Neighborhood Watch meeting. There has been a 5% increase over the past year, but there hasn't specifically been a recent spike in activity. Might it be because of the train station opening? Things we might also want to discuss that MM noted from the AG NHW meeting: the possibility of live streaming CCTV footage app (RM suggested Blue Iris); suggestion of having a list of the locations of everyone that has CCTV for reference to be kept by the residents group. **Community Projects** [7.40] Dog Parks. JM mentioned that Carol said the Dog Park is definitely happening, and JM has asked for information from Carol regarding the details. Forecast is to have it in Honeywood Rise. They're fast tracking it now that they've realised all the residents really want is an off-leash area rather than a high-tech dog park. AS notes that we really need to be clear about our role as an intermediary so that our members don't hold us responsible for decisions made by the council. We also need

	to communicate to the council that we are happy to communicate the information to our members, but cannot make a decision on behalf of our members. - PD raised it with M, and M was going to message AS to follow up. PF has mentioned that this is in the pipeline, and is on the budget already.
